Bridge Project Update- The overall discussion was tabled. The Board of Selectmen would like to have an additional meeting with Hoyle and Tanner to have a better understanding prior to moving forward with a decision.

Selectman Jean would like to freeze the Road Betterment Account until a decision is made about how to proceed with the Bridge project.

MOTION: On a motion by Selectman Jean and seconded by Chairman McWhinnie it was approved to freeze the Road Betterment line. (3-0 Voice Vote – Chairman McWhinnie-yes, Selectman Bishop-yes, and Selectman Jean-yes).

 - Maintenance shim on different areas on Middle Route
 - > Two days of Crack sealing, and regular maintenance on roads which includes ditching, replacing culverts etc.

The Select Board would like estimates on paving for the next Board of Selectman meeting.

In the future, the Select Board will need to have a discussion with the Police, Fire, Highway and the School in order to get feedback on the Crystal Lake Bridge project.

Oak Crest Lane Complaint- Map 413/ Lot 73 – 76 Oak Crest Lane

Mr. Roy and Mrs. Kim Dussault

Numerous complaints and reviews for various complaints.

Mr. Roy- Trash, junk cars, boats, oil tanks, barring things at night, concerned about well contamination, it looks like a junk yard, they have state children there and doesn't understand how they are allowed to have kids in those conditions. The complaint goes back since 2010.

Mrs. Dussault- She can see everything from her back deck, the fence is falling down, concerned about well contamination due to barring things in the yard such as computers.

Town Administrator- Suggested that they call DES for the well contamination and ground contamination concerns and will forward the complaint to the health officer and code enforcement. Clarification was made that due to RSA specification the Town is limited in health enforcement. If there are additional concerns about the welfare of children the suggestion is to reach out to the appropriate state agency.

Mr. Roy- There is work being done at all hours, compressors running out of the garage on the property, concerns that the garage has been permitted, and running a business.

Mrs. Dussault is willing to have Town Officials to access her property so they can view the mess she is describing.

Selectman Jean is concerned there is an illegal business being run and will stop by to look at the issue.

Mr. Roy would like a follow up meeting with the Board. The office will be in contact to set up a time for them to come in again.
