**6:01p.m.** Chairman McWhinnie opened the meeting, took attendance of those present and voting (Chairman McWhinnie, Selectman Bishop and Selectman Jean,) and led the Pledge of Allegiance.

• Grader Repairs- new quote, engine rebuild/overhaul: \$26,631.84
Discussion on a list of repairs for the grader, yearly maintenance, full fluid changes, hydraulic oil-\$270.00, leaky shift cylinder-\$2,446.07, and \$524.88 for the original diagnostic work. Total work without trucking fees are \$27,873.79; trucking fees will be approximately \$450.00. The Board agrees to have the work done, the yearly maintenance will be done through CAT, and will be paid out through the grader repair line.

A purchase order for Bobcat tires in the amount of \$3,039.96 to Bobcat of NH for the replacement of all four tires. The Board of Selectmen have requested that two additional quotes for tires to be given. Selectman Jean suggested calling Stratum Tire and Belknap Tire for additional quotes and that the tools be purchased from Home Depot for warranty purposes.

Selectman Jean directed Administration, in addition to the regular posting on the Town website and the Town Hall, a closing notice for Easter should be placed at the Transfer Facility so that it is visible on the gates and outside on the buildings for residents to see.

#### **New Business**

• Gilmanton's Own, Inc: Mrs. Sarah Welcome-Baldwin presents to the Board of Selectmen an update on Gilmanton's Own Inc, their plans for a future property, the events that highlight the local farms in the area, their future plans for growth to promote local agriculture, the possibility of being able to offer a scholarship to a student who is interested in higher education for agriculture, grants and the plans for 2-3-year time frame for the non-profit organization.

#### Mr. Justin Caldon-

• Asked about the process for re-appointment to a board.

- Asked if or when the yearly process of voting for a Chairman of the Board will take place because it has been typically done on a yearly basis.
- -Chairman McWhinnie stated that it is his understanding that there is no set time to vote on the Chairman's position and that it can be done at any time during the year.

# Mrs. Rachel Vigeant-

- Asked the Board members to strongly reconsider having a member of the Planning Board placed as an Alternate to the ZBA because she believes it to beneficial for residents going through the process of dealing with both the Planning and Zoning Boards to have a member that has been at both meetings.
- -Chairman McWhinnie stated that it would be taken under consideration.

#### Mrs. Brenda Currier-

- Asked if the Board has the information on whether or not the Transfer Facility is actually recycling the items or dumping it in the trash.
- -Chairman McWhinnie stated that all the recycling is being recycled.
  - Questioned the re-appointment of Nate Abbott last month vs other members being held back for re-appointment, she believes the lack of re-appointments is discriminatory.
- -Chairman McWhinnie believes that all re-appointments have been presented as they come in to the office and reaffirms that the boards decision is not based in discrimination.

#### Mrs. Jenni Hackala-

- Questioned how the Board responds to public comments, if the Chairman is the only one that speaks and if the Board is acting together why does the Chairman say I instead of we.
- -Chairman McWhinnie stated that he should be saying we instead of I, thank you.

#### Mrs. Sandi Guarino-

- Questions the unfairness in the process of re-appointments and believes that the men that were not re-appointed should be given a reason.
- -Chairman McWhinnie agrees that the member should be given an explanation for their denials and response will be given

My name is SBW and I live at 113 Pancake Hill Rd. Gilmanton growing farm is Pancake Hill Farm and of course many of you know I own Provincial Palate Catering and Specialty mustards.

I have been asked to present our Concept and I defer to my peers when time for answering questions from the board.

#### 1. The Event-Taste of Gilmanton

• Taste of Gilmanton Event- several farmers and 2 Chefs joined together to promote and provide an event serving food prepared with all local ingredients from Gilmanton Farms.

## 2. The Organization-Gilmanton's Own Inc.

- This base group of farmers decided to form an organization to provide and promote local Farms and Agriculture. It was decided that all monies made above and beyond upkeep of the organization would be gifted in the form of a Scholarship to a Gilmanton Student that is furthering their education in Agriculture.
- Filed Articles of Agreement to form Gilmanton's Own Inc. a non-profit Organization. Have filed request to be a 501C-3 status
- It became apparent that we needed a central location to provide a place to promote Farms and Products in Gilmanton.
- Created Mission Statement: Gilmanton's Own, Inc. is a non-profit association aimed to
  preserve and promote agriculture opportunities in Gilmanton, to provide farmers with a
  voice and outlet to distribute local products and to keep farming viable and vibrant in
  our community.

#### 3. The 4 P's-

- PRESERVE the integrity of Agriculture and the Farmers in Gilmanton. Possibly a Property
- PROTECT the integrity of Agriculture and the Farmers in Gilmanton
- PROMOTE Farmers, organically grown & sustainable agriculture & education

- **PROVIDE** Local produce, pasture-raised beef, free range pork, lamb, free range poultry, eggs, turkeys, milk, butter and dairy products, honey, handmade mustards, artisan breads, maple syrup and maple products, strawberries, blueberries, raspberries, peaches, organic flowers & edible herbs, jams, jellies, granola, fruit spreads, pickles, hot pepper fudge, dried herbs, homespun yarns, crafts, locally brewed soda.
- 3. The Grant- Blessed to have Lucinda Williams who has helped us write and submit this first grant application. We have applied for a USDA Grant. It would provide funds for Feasibility and Parking Studies on several possible sites.
- 4. The Location- Several Different locations will be considered in the feasibility Study. Barn-Firehouse.
