Line- 01-4130-110- Requesting placement on the scale and a one-step increase Line- 01-4130-115- Wages have been adjusted due to the reclassification, adjusted the job description and personnel action form

Line- 01-4130-130- Request for an increase for the Selectmen's pay, the Board requested the pay comparisons in surrounding towns before moving forward with further discussion.

Line-01-4130-210- Health Insurance- This line is staying the same at \$5,000 for Department Head request.

Line- 01-4130-270- Training-Discussion about training for the Town Administrator for a course/certification for Public Supervisor, total budget request is \$2,000.00 The Board requested the line be increased another \$1,000.00 to allow training for another employee, for a total request of \$3,000.00.

Line- 01-4130-271- Appreciation- The Board would like to increase the amount by \$1,500.00 in order to be able to offer an appreciation to other Boards and Committees.

Line- 01-4130-341- This line will be updated to reflect the night's prior motion to allow the phone purchase for the Chairman of the Board of Selectman.

Line- 01-4130-429- Town Website- Administration is putting together an RFP to receive proposals for a new website, general information that has been received on pricing is in the price range of \$4,500.00-\$6,000.00, moving forward with an RFP will allow for solid answers for pricing.

MOTION: On a Motion by Chairman McWhinnie, and seconded by Selectman Bishop it was voted to move forward the Assessing budget. (2-0 Voice Vote – Chairman McWhinnie-yes and Selectman Bishop – yes).

Future discussion will be needed on the Old Town Hall and it's use and future.

Animal Control- Budget remains the same

MOTION: On a Motion by Chairman McWhinnie, and seconded by Selectman Bishop it was voted to move forward the Animal Control budget. (2-0 Voice Vote – Chairman McWhinnie-yes and Selectman Bishop – yes).

Outside Agencies- Tabled

Welfare/Human Services- Budget remains the same

MOTION: On a Motion by Chairman McWhinnie, and seconded by Selectman Bishop it was voted to move forward the Welfare [Human Services] budget. (2-0 Voice Vote – Chairman McWhinnie-yes and Selectman Bishop – yes).

Parks and Recreation-

Line-01-4520-115- Wages -Department Head requested increase

Line-01-4520-390- Swim Instructor- increase due to increase in enrollment and the need for more help.

MOTION: On a Motion by Chairman McWhinnie, and seconded by Selectman Bishop it was voted to move forward the Parks and Recreation budget to the Budget Committee. (2-0 Voice Vote – Chairman McWhinnie-yes and Selectman Bishop – yes).

Library-Corner Library

MOTION: On a Motion by Selectman Bishop, and seconded by Chairman McWhinnie it was voted to move forward the Library budget as presented. (2-0 Voice Vote – Chairman McWhinnie-yes and Selectman Bishop – yes).

Patriotic Purposes-

MOTION: On a Motion by Selectman Bishop, and seconded by Chairman McWhinnie it was voted to move forward the Patriotic Purposes budget as is to the Budget Committee. (2-0 Voice Vote – Chairman McWhinnie-yes and Selectman Bishop – yes).

Conservation-

Line- 01-4611-115- Wages- The Board reduced this line to \$1,300.00, which will affect the lines for FICA and Medicare.

MOTION: On a Motion by Selectman Bishop, and seconded by Chairman McWhinnie it was voted to move forward the Conservation budget with the change to Line 01-4611-115 to show \$1,300. (2-0 Voice Vote – Chairman McWhinnie-yes and Selectman Bishop – yes). Reduction to the lines for FICA and Medicare will be reflected

Debt Service-

MOTION: On a Motion by Selectman Bishop, and seconded by Chairman McWhinnie it was voted to move forward the Debt Services budget as is to the Budget Committee. (2-0 Voice Vote – Chairman McWhinnie-yes and Selectman Bishop – yes).

Milfoil request will be moved into the budget as a line item.

Finance Director stated to the board that there is future conversation and approval needed for a default budget and revenues.

Adjournment: On a Motion by Chairman McWhinnie and seconded by Selectman Bishop it was voted to adjourn at 7:32 p.m.(2-0).
