## Board Recommendation as stated by Selectman Warren:

In light of the MRI report, there is a significant need to hire more police officers. Unfortunately, the Board of Selectmen has not received any feedback from the Chief, not getting any forward motion on any hires. It is disappointing because we really wanted to work with the Chief but our Town really needs the coverage. So, I think it is important that we allow our Town Administrator to work with an outside company to recommend qualified candidates to fill those two vacancies within the Police Department, & to bring those

recommendation to the Board. We are willing to work with the Chief in that process but we definitely need to move forward. It would be wise to allow our Town Administrator to work with an outside company to begin that process.

Board consensus agree (3-0).
