#### **Open Public Meeting**

Meeting was open to public attendance in the auditorium of the Academy Building. Meeting was also live Streamed on the Town Facebook page.

**Present:** Chairman Mark Warren, Vice-Chairman Vincent Baiocchetti, Selectman Collins and Town Administrator Boré (Gilmanton Academy building – Auditorium).

Call to Order - 6:05 p.m. Chairman Warren

Chairman Warren opens the meeting and leads the Pledge of Allegiance.

Kevin Guerrier, a town resident for over 30 years, presents a donation from Wise Foods where he is an employee. Wise Foods has created a plan and product to say "Thank You" to front line city and state employees such as Fire, Police and Public works for their work during this pandemic. Mr. Guerrier presents a donation of Wise Potato chips to be distributed to front line town employees (See Attached letter). A brief photo shoot with selectmen and Police chief ensues.



#### PUBLIC MINUTES APPROVAL

**MOTION** On a motion by Vice-Chairman Baiocchetti and seconded by Selectman Collins, it was unanimously voted to approve the Minutes from 09-11-2020 (Chairman Warren – yes, Vice-Chairman Baiocchetti – yes, Selectman Collins – yes).

#### • NH Dams Loon Pond Dam Agreement for stoplogs/enclosure: \$5,240 (WA#33)

WA#33 was voted for at the March Town Meeting to raise and appropriate \$7,750 to complete the replacement of the stoplogs and to build an enclosure by the dam to secure the logs when not used at the dam as well as store spare ones and other materials.

The difference between the voted appropriation and the Agreement amount relates to the redoing of the walking bridge above the dam, which can wait until next year. The \$2,500 difference will be encumbered to fund the replacement of the walking bridge next year.

**MOTION** On a motion by Vice-Chairman Baiocchetti and seconded by Selectman Collins, it was unanimously voted to approve the NH Dams Agreement in the amount of \$5,240 and to authorize Chairman Warren to execute the Agreement on behalf of the Board (Chairman Warren – yes, Vice-Chairman Baiocchetti – yes, Selectman Collins – yes).

#### • Quitclaim Deed - Map 421, Lot 008

This pertains to the repurchase by its owner under RSA 80:89 of the property located at Map 421, Lot 008. The property was tax deeded on May 7, 2018. The taxpayer tendered payment in full for all back taxes, interest, costs, and the penalty set forth in RSA 80:90. A total payment of \$5,027.06 was received.

#### Sugarloaf Ambulance P.O.: \$72,615 (WA#12)

Final payment for the remount of the Fire Department ambulance A1.

 **MOTION** On a motion by Chairman Warren and seconded by Vice-Chairman Baiocchetti, it was unanimously voted to approve the Consent Agenda as amended. Amendment pertains to the addition of the Sugarloaf Ambulance P.O. which was not part of the posted Consent Agenda (Chairman Warren – yes, Vice-Chairman Baiocchetti – yes, Selectman Collins – yes).

#### **OLD BUSINESS**

Public Hearing for Transfer Station Fee Schedule and Emergency Order #56 rescheduled

These Public Hearing require a minimum 7 days prior notification in a local paper. At the 9/11 BOS Meeting, the Board agreed to have the public Hearing for the Transfer Station New Fee Schedule on 9/21 and the one on EO #56 on 10/5. T.A. Boré states he was unable to have the hearing advertised in the Daily Sun on 9/14, therefore not being able to meet the minimum notification requirement for having the Public on 9/21.

After checking with Town Counsel, there is no prohibition on having two public hearings on two un-related matters on the same night.

T.A. Boré recommends to schedule both hearings on 10/5, starting with the hearing on the Transfer Station New Fee Schedule at 7PM and, when done, proceed with the one on EO#56.

T.A. Boré confirms he received budget recommendations and capital requirements from most Department Heads. Some are having difficulties getting required vendors quotes, but there will be time to catch up with that in the process. Next, Outside Agencies are to submit their Request for Funding Forms to Town Administration by September 25<sup>th</sup>. Town administration and Finance will compile all data and present the recommendations to the Board.

The Fire Chief has asked to be placed on the BOS Meeting Agenda on October 5 to discuss current staffing pattern and needs going forward which include the application of a FEMA SAFER grant which will allow to acquire and fund additional staff.
