### Fire Department -

26 Article for portable radios for the Fire Department. Arthur Capello will check with the Fire 27 Chief to see if that the number of radios listed is required. The Selectmen would like to also 28 have a cost for each of the radios. The Board is not denying the need for radios, but would like 29 clarification on amount of radios and cost. (The cost over a 4-5 year plan was \$14.500/year as 30 requested). Selectman Guarino and Chairman Currier said that they have not seen this large of a dollar amount on a non-capital reserve, should be a capital reserve.

Road Ditching - \$50,000 to contract out ditching of roads. The Selectman were in agreement about this Warrant Article.

Road Agent - The Warrant Article to have the Road Agent as an appointed position as opposed to the current elected position was discussed. Selectman Guarino does not support it, because there will be an elected Road Agent, serving one year into his elected three year term. Arthur Capello said he will speak with Town Counsel regarding the proper wording of this Warrant Article. Chairman Currier said there is no opportune time to begin this. There is a lot of talk about having an appointed Road Agent. Selectman McCormack said we need to know how the Town feels. Arthur Capello called for a formal vote from the Selectmen.

Article #XX: "Shall the Town of Gilmanton raise and appropriate as an operating budget, not including appropriations by special warrant articles and other appropriations voted separately, the amounts set forth on the budget posted with in the warrant or as amended by vote of the first session, for the purpose set forth therein totaling Three Million Three Hundred Eleven Thousand Nine Hundred Fifty Eight Dollars (\$3,311,958)? Should this article be defeated, the default budget shall be Three Million Three Hundred Twenty One Thousand Six Hundred Thirty Thousand (\$3,321,630), which is the same as last year, with certain adjustments required by previous action of the (Town) or by law; or the governing body may hold one special meeting, in accordance with RSA 40:13, X and XVI, to take up the issue of a revised operating budget only."

Tax Impact about:

Article #XX: To see if the Town to establish a non-capital reserve fund called Fire Portable Radio Replacement Non-Capital Reserve Fund and to appoint the Board of Selectman as agents to expend and to further see if the town will vote to raise and appropriate the sum of Fourteen Thousand Five Hundred (\$14,500) from general taxation to fund the Fire Portable Radio Replacement Non-Capital Reserve Fund. Current balance: \$0.00 Tax Impact about: .03

Article #XX:—To see if the Town will vote to raise and appropriate the sum of Forty Seven Thousand (\$47,000) to replace the corners Forestry/utility truck. And to further fund this appropriation the withdrawal of Forty Seven Thousand (\$47,000) from the Capital Reserve Forestry Vehicle Fund.

This does not include call fire fighters or elected officials except in named in this article. This will then become part of the default budget as of 2016.
