5:00 pm - Chairman Rachel Hatch called the meeting to order. Present were Chairman Hatch, Selectmen Ralph Lavin and Brett Currier and Recording Clerk Lois Dionne.

FYIs & Other Business

Insurance – Old Corners Fire Station – It had been brought to the Selectmen's attention that the old corners fire station building was still listed on the Town's insurance policy. Lois was asked to contact the Firemen's Association, and inform them that since the building had been turned back over to them they would have to get their own insurance on the building. Lois said Chief Hempel had asked if they could pay a premium and keep the building on the Town's policy until they turn the building over to the Owens.

After a brief discussion, it was the consensus that the Selectmen had told residents the Town was severing all ties with the building once the safety building was completed and that the Firemen's Association would have to get their own policy, and should pay a premium for the time that it has been being carried on the Town's policy since they took the building over.

Laptop – Land-Use Clerk – Lois informed the Selectmen that land-use clerk, Annette Andreozzi's, laptop computer had not been fixed as had been previously thought, and she did still need a new laptop computer. Annette was in the office, so the Selectmen spoke with her about the computer. After discussion, Annette was given permission to go ahead and order a new laptop computer.

GAT – The tonnage Gilmanton sent to Penacook in December 2012 was 94.12 tons, down from 97-9 tons last year.

Financial Assistance – The Town received application forms from the state for Financial Assistance for Highway and Safety grants projects. Copies of the forms will be forwarded to the Highway Department, Police Department, Fire Department and the Roads Committee.
