**NOTICE TO THE COMMUNITY:** It has been brought to the attention of the Board of Selectmen & the Department of Environmental Services that there are individuals who are improperly disposing of hazardous waste. This is problematic for the health and safety of the community, staff and against the law set forth by the State of New Hampshire.

These actions of a few individuals will affect the whole community. Potential closure of the facility and monetary fines are steps that could be taken if the organization cannot comply. If individuals are caught illegally disposing of hazardous waste, action by law enforcement may be taken.

- **HOUSEHOLD TRASH & SINGLE STREAM RECYCLING ONLY**

Household trash & single stream recycling are the only items being taken at the Transfer Station Facility Currently. This is because NHDES conducted an inspection on April 27<sup>th</sup>, 2023, and has deemed the current state of the facility as deficient due to the mismanagement of waste. The mishandling of waste materials cannot continue, and the Town is committed to the remediation of the facility.

**OIL BASED PAINT = HAZARDOUS WASTE-** Oil based paint is considered hazardous waste and must be taken to an appropriate disposal or drop-off center and cannot be disposed of with your regular trash in the compactor.

**NH STATE LAW RSA 149-M:58 PROHIBITS DISPOSING OF MERCURY-ADDED PRODUCTS IN SOLID WASTE LANDFILLS AND INCINERATORS**

- **NO MERCURY!**

**Mercury Containing Devices:** Thermometers, Thermostats, electrical switches, Mercury Button Cell Batteries, Fluorescent Light Bulbs-including compact fluorescent bulbs.

**NH STATE LAW RSA 149-M:27 PROHIBIT DISPOSING OF THE FOLLOWING MATERIALS IN SOLID WASTE LANDFILLS OR INCINERATORS: E-WASTE SUCH AS COMPUTERS & COMPONENTS, TELEVISIONS (INCLUDING PLASMA & LCD'S) FAX MACHINES, DVD PLAYERS-VCR'S, PRINTERS, MICROWAVES**
